Key Benefits of the Business Partnership

- You and your employees receive free or discounted admission to The Wild Center
 - There are a set number of free adult passes at each member level (see other side), which are digital passes on your account and redeemed at the Admissions counter.
 - Once those free passes are used, your employees are admitted at a discounted rate of \$10/adult, for up to 2 adults. Their related children (age 17 or under) continue to be admitted at no cost.
- Provides a wellness benefit to your employees.
- Opens employee perspectives on the natural world in a family-friendly environment.
- Recognition on our website – wildcenter.org.
- Discounted use of Wild Center facilities for meetings or special events.
- Special benefits and invitations for the owner/manager or other primary contacts.

Free and Discounted Admission to The Wild Center

Use the free passes how you like, and once they have been used, your employees will be admitted to The Wild Center for \$10 per adult (more than 50% off our summer rate) – for up to two adults – anytime they want to visit during your membership year. Their related children under age 18 will continue to be admitted for free. To receive the discounted rate at the Admissions, your employee should be ready to identify themselves as associated with your organization (e.g., employee ID, business card, etc.). If you are sharing your admission benefits with others – colleagues, partners, family, etc. – you can provide them with documentation for our admission staff, or call/email ahead about their visit.

Hold your Meeting or Event at The Wild Center

The Wild Center has a variety of options for a reception, meeting or celebration. You’ll receive a discounted facilities use fee for all we have to offer: Hutchens Conference Room (seats 20 at the table, plus 10 more), the 165-seat Flammer Theater, and the Big Wolf Great Hall which accommodates 150 people. During the summer and fall, the outdoor Esplanade Tent is available and seats 150. Holding a reception on Wild Walk also is a possibility (seasonally, and weather permitting). Facilities are available at mutual convenience and when reserved in advance.

- 5% off purchases in the Waterside Café, 10% on Member Day each week
